Market comment Ringler Research:

The (positive) outcome of Section 232 petition in the US may be the crucial catalyst in 2019 for the launch of a new bull market!

When will US utilities finally return to the uranium market and either cover themselves by buying uranium on the spot market or enter into new long-term delivery contracts with uranium producers? Well, the Department of Commerce (DOC) must submit a recommendation to the US President by April 14, 2019 on how to deal with Section 232 petition. Afterwards, President Trump has a maximum of 90 days to make a decision. In the petitions on steel and aluminum imports, Trump announced a decision after just a few days! April could be very exciting for the uranium sector and involved investors. Should the petition be granted, the few US producers / developers in particular should benefit, as US utilities may have to meet quotas on how much uranium they need to source from domestic US production. With a positive petition decision, the entire price base for uranium should shift significantly upwards. This would be the long-awaited trigger for a stronger upward movement for the remaining 62 companies in the uranium sector.





The market cap of all exchange listed companies from the uranium sector increased 5,6% from 11,8 to 12,4 Bln. USD since 31.12.2018. Around 500 companies were active in the sector at the peak (2000-2007) of the last major bull market, currently the number of exchange listed companies (62) is much lower!

Interview with Jordan Trimble, CEO of Skyharbour Resources at the PDAC convention in March 2019

About Skyharbour Resources / introduction:

Skyharbour Resources (TSX-V: SYH) (Frankfurt: SC1P) (OTCQB: SYHBF) is a preeminent uranium and thorium exploration Company with projects located in the prolific Athabasca Basin of Saskatchewan, Canada which was ranked as the best mining jurisdiction to work in globally by the Fraser Institute in 2017. The Company has been acquiring top tier exploration projects at attractive valuations culminating in five uranium properties totalling approx. 200,000 hectares throughout the Basin. In July 2016, Skyharbour secured an option from Denison Mines (TSX: DML), a large strategic shareholder and partner of Skyharbour's, to acquire a 100% interest in the Moore Uranium. Skyharbour now owns 100% of the flagship project which hosts the high grade Maverick Zone where previous drilling has interested grades as high as 21% U3O8 over 1.5m. The Company is run by a strong management and geological team who are major shareholders with extensive capital markets experience as well as focused uranium exploration expertise in the Basin.

Question by Ringler Research: What differentiate Skyharbour from its peers? What are the top arguments to buy Skyharbour Resources right now?

Answer Jordan Trimble, CEO of Skyharbour Resources:

Given the prolonged downturn in Uranium prices and equity market sentiment for the better part of the last decade, the universe of investable Uranium exploration companies has dwindled to only a handful of names. Skyharbour is unique amongst the remaining group in that it has mix of projects that span from Advanced Stage to Grass Roots exploration; and employs a dual-track model of Company-funded exploration and pure-play discovery exposure (example: the Flagship asset Moore) and partner funded exploration (prospect generator model) at Preston and East Preston. Skyharbour is managed by a balanced team with representatives holding capital markets, mineral exploration and discovery, and mine development credentials. The company is well-funded through upcoming work programs and is poised to enjoy robust news flow with several upcoming catalysts: drilling is currently commencing across three projects, including at the company's flagship asset – the high grade Moore project.

Question by Ringler Research: Which milestones / potential corporate news can we expect in the next 6-9 monthes?



Answer Jordan Trimble, CEO of Skyharbour Resources:

Skyharbour expects to carry out additional exploration and drilling programs at its flagship Moore Project over the course of the upcoming year. Given the success of the 2017/2018 drilling programs, the company recently announced the commencement of a winter diamond drilling program of a minimum of 3000m. The Moore project will provide steady newsflow over coming months supplemented by news from partner funded projects and prospect generator transactions. Skyharbour's trategic partner Orano Canada (previously AREVA) has commenced its 2019 winter diamond drilling program consisting of 11 to 15 drill holes for a total of approximately 3,600 metres on the Preston Project. Drilling will test targets defined by the 2018 EM surveys on the JL and FSA target grids. The estimated cost of the 2019 exploration and drilling programs is \$2,200,000. Orano must spend \$8 million over a 6 year period to earn up to 70% of the Skyharbour's Preston project. More recently, Azincourt Energy announced that it had mobilized drill crews to Skyharbour's East Preston Uranium project. Azincourt has to spend \$3.5 million over a three year period to earn 70% of the project.

Question by Ringler Research: How is the sentiment in the uranium space at the moment? What is your medium term expectation for the industry and the uranium price?

Answer Jordan Trimble, CEO of Skyharbour Resources:

The uranium market has recently shown notable signs of recovery with increasing uranium prices and improving sentiment, and this recovery appears to be accelerating amid recent news and several sector developments. The demand side continues to grow and Japanese nuclear restarts have recently accelerated. On the supply side, mine closures and production curtailment continue to dominate headlines. The two largest producers, Cameco and KazAtomProm, have announced large supply cuts in 2017 and 2018 including Cameco's suspension of operations at the world's largest uranium mine, McArthur River, as well as KazAtomProm's announcement that it will cut 20% of planned production over the next three years as well as another 6% production cut over previous expectations. A new uranium holding company called "Yellow Cake" raised US \$200 million in a London-based IPO and has bought 8.1 million lbs of uranium from KazAtomProm representing a significant portion of the uranium spot market. There has also been recent talk that current producers are more likely to buy larger quantities of material from the spot market going forward including Cameco announcing it would by 11-15mm lbs in the spot market through 2019 which should add upward pressure to the uranium price. Lastly, the findings and ruling on the Section 232 Investigation currently underway in the USA should help bring the dormant US nuclear utilities back to the market once they have guidance on how much uranium they need may need to source domestically.

Interview with Daniel Major, CEO of GoviEx Uranium at the PDAC convention in March 2019

About GoviEx Uranium / introduction:

GoviEx Uranium Inc. (TSX.V: GXU; FSE: 7GU; OTC MKTS: GVXXF) is a mineral resource company focused on the exploration and development of its African uranium properties. GoviEx's principal objective is to become a significant uranium producer through the continued exploration and development of its mine-permitted Madaouela Project in Niger, its mine-permitted Mutanga Project in Zambia, and it's Falea Project in Mali.

Question by Ringler Research: What differentiates GoviEx Uranium from its peers? What are the top arguments to buy GoviEx Uranium right now?

Answer Daniel Major, CEO of GoviEx Uranium:

GoviEx has the required Mine Permits on both of its Madaouela and Mutanga Projects. Hence, with the uranium price forecast to continue its recovery through 2019 GoviEx is able to advance the development program for the Madaouela Project, with the potential to be in production approximately three years from now. A limited number of our uranium peers have their mining permits, and therefore risk not being able to fully benefit from the current uranium price recovery.

We would expect the share prices of all listed uranium companies to rise with increasing uranium price. However, we note that that producing uranium companies trade at a marked valuation premium relative to their development peers. GoviEx is one of a limited number of uranium companies that benefit from both the uranium price recovery and the transformation from developer to producer.

Ringler Research question: Which milestones / potential corporate news can we expect in the next 6-9 months?

Answer Daniel Major, CEO GoviEx Uranium:

GoviEx's milestones and corporate news will predominantly come from its development associated with Madaouela. This will include potential updated on technical develops from the feasibility study, and the ongoing work related the financing of the project including debt and offtake.





Ringler Research question: How is the sentiment in the uranium space at the moment? What is your medium term expectation for the industry and the uranium price?

Answer Daniel Major, CEO GoviEx Uranium:

Global nuclear energy generation has returned to the levels last seen in 2011. The rate of global reactor construction is now at the highest level in the past 25 years. With the announcement recently of six new power reactor construction starts in China and the restart of nuclear reactors in Japan, we should expect the level of nuclear energy generation to continue its rise.

The supply constraint shouldered by the major uranium producers, combined with the increase in uranium inventories shifting to investment funds, has resulted in the supply of the yellow metal being in a deficit with forecasts now indicating that the uranium price will continue to rise through 2019.
